## SOFTWARE LICENSE AGREEMENT

SWK Technologies, Inc. licenses this software subject to the terms and conditions hereinafter set forth.

IMPORTANT: PLEASE READ THESE TERMS BEFORE INSTALLING THE PRODUCT, IF YOU INSTALL THE PRODUCT YOU ACCEPT THE TERMS AND CONDITIONS OF THIS LICENSE. If you do not agree with these terms, DO NOT INSTALL THE PRODUCT, and contact your vendor within ten (10) days for a refund.

- I. DEFINITIONS. In this License Agreement, the words "you", "your", "Licensee" and "Customer" each mean the person or entity named on the registration form provided below as the Customer, and "we", "us", "our", "Licensor" and "SWK" each mean SWK Technologies, Inc. The term "Program" means (1) instruction or statements in machine-readable form, (2) any text or data in machine-readable form, and/or (3) any documentation in either machine-readable or printed form. The term "Software" means Programs SWK has supplied to you in response to your orders.
- II. LICENSE. SWK, a corporation organized and existing under the laws of the State of New Jersey, as Licensor and owner hereby agrees to grant you as Licensee a non-exclusive license to use the enclosed Software subject to the terms and restrictions set forth in this License Agreement. The right to use the Software in accordance with the terms of this License Agreement is the only right herein granted and delivery of a copy of the Software to you is made solely to enable you to exercise this right.
- III. OWNERSHIP. SWK shall at all times retain all title in and ownership of the Software and all Programs and Program enhancements or modifications, including translations, compilations, partial copies and portions of updated works. SWK reserves all rights to all patents, copyrights, trade secrets and any other intellectual properties regarding the Software. You may not remove or obscure and copyright or trademark notices.
- IV. COPYRIGHT. This Software is copyrighted and all rights are reserved by SWK. You may not copy or reproduce any part of the Software for any purpose. The distribution of the Software is intended for the use of the original Licensee only and for use only on the computer systems specified. Lawful users of this Program are hereby licensed only to read the Program from its medium into the memory of a computer only for the purpose of executing the program.
  - a. The documentation is also copyrighted and all rights are reserved. The documentation may not, in whole or in part, be copied, photocopied, reproduced, translated, transmitted or reduced to any electronic medium of machine readable form without prior consent, in writing, from SWK Technologies, Inc.
  - b. The Licensee recognizes that SWK Technologies, Inc. has expended considerable time, effort and money to develop the licensed Software and Manual and that SWK Technologies, Inc. will be substantially damaged by its unauthorized use, sale or distribution. In addition to recovery of all damages and the obtaining of injunctive relief as provided by law, in the event legal action must be taken to enforce this provision, the Licensee will pay SWK, Inc, all reasonable legal fees incurred in enforcing the rights of SWK Technologies, Inc. under this provision.

delivered to us at the address stated on our invoice. Payments that are due and not paid within 30 days of their receipt by you shall accrue interest at the rate of 1 and 1/2 % percent per month.

- VII. RESTRICTIONS ON USE AND TRANSFER. Unless it has been agreed otherwise, in writing, you may load and use the original and any backup copies of the Program and its documentation only with a single computer or network fileserver. You may physically transfer the Program from one computer to another, provided that the Program is used in connection with only one computer or network fileserver at a time. You may temporarily use the Program on another computer when the original unit is inoperative because of a malfunction. You may not distribute copies of the Program Documentation to others. You will assume all incidental or consequential damages that result from any defect in the Software, even if SWK Technologies, Inc. has been advised of the possibility of such damages.
- IX. NO OTHER WARRANTIES. No dealer or distributor of SWK Technologies, Inc. products or any agent of SWK Technologies, Inc., is authorized to make any representation of warranty with respect to the Program except those expressly stated in this Software License Agreement.
- X. LIMITATION OF LIABILITY. UNDER NO CIRCUMSTANCES WILL SWK Technologies, Inc. OR ANY OF OUR VENDORS, LICENSORS OR SUPPLIERS BE LIABLE FOR LOSS OF DATA, LOST REVENUE OR PROFITS, OR FOR ANY OTHER SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, EVEN IF THEY WERE FORESEEABLE OR YOU HAVE INFORMED US OF THEIR POTENTIAL. OUR TOTAL LIABILITY TO YOU FOR DAMAGES UNDER THIS LICENSE AGREEMENT IS LIMITED TO, AND IN NO EVENT SHALL EXCEED, THE LICENSEE YOU ACTUALLY PAID US FOR THE SOFTWARE.
- XI. TERM. This license is effective until terminated. You may terminate it at any time by returning the Program and Documentation together with all copies, modifications and merged portions in any form to SWK Technologies, Inc. The license will also be terminated by SWK Technologies, Inc. immediately and without notice if you fail to comply with any term or condition of this License Agreement.
- XII. ACKNOWLEDGMENT. You acknowledge and agree that this License Agreement allocates risk between you and SWK Technologies, Inc. as authorized by law, and that the price of the Program reflects such allocation of risk. If any remedy provided in this License Agreement shall be deemed by a court of competent jurisdiction to have failed of its essential purpose or purposes, the limitations of liability and exclusion of damages set forth in this License Agreement shall continue in full force and effect. Your installation of this software acknowledges that you have read this Customer License Agreement and agree to its exclusive statement of the

agreement between yourself and SWK Technologies, Inc. and supersedes any proposal or prior agreement, oral or written, and any other communications between yourself and SWK Technologies, Inc. or dealers and distributors of SWK Technologies, Inc. products relating to the subject matter of this agreement.

- XIII. ASSIGNMENT. You may not sublicense, assign, sell, transfer, or lease this license or the Software, without our written consent, which consent may be unreasonably and arbitrarily withheld.
- XIV. TERMINATION. You may terminate this License Agreement at any time for your convenience by giving 30 days' written notice to SWK. Inc. You will not be entitled to any refund of any fee that is then already due or paid. Either party may terminate this License Agreement at any time if the other party fails to comply with the terms of this License Agreement. Upon termination of this License Agreement for any reason whatsoever, you will return to us all copies of the Program including, but not limited to, the Software and all program documentation in your possession or under your control.
- XV. GOVERNING LAW AND DISPUTE RESOLUTION. New Jersey law shall govern this License Agreement and the courts of the State of New Jersey and the U.S. District Court for the State of New Jersey shall have exclusive jurisdiction for the resolution of all disputes arising under this License Agreement. By installing the software, you consent to the personal jurisdiction of such Courts over you,

Notices to Customers shall be provided to the address, at which the Software was registered, or to a new address if SWK has been properly notified of the change. Notices to SWK Technologies, Inc. shall be sent to 5 Regent Street, Suite 520, Livingston, New Jersey 07039, or such other address as we may notify you. Notices shall be effective upon receipt. We may revise any of the terms of this License Agreement to comply with changes in the law regarding software licensing or a change in the requirements imposed on us by one of our licensors or vendors, by providing you with 15 days' notice of the change. Neither party will be liable to the other for any delay or failure to perform if the delay or failure results from a cause beyond its reasonable control.
