About Unify Square, Inc.

Unify Square, Inc. is a cloud software and services provider headquartered in Bellevue, WA. Founded in 2008 by a former Microsoft developer, their software offerings were initially well-known for enhancing Windows communication platforms such as Skype for Business and Microsoft Teams. However, they have since expanded support to several other collaboration applications including Slack, Zoom and Workplace by Facebook, and consolidated their software suite into a single SaaS solution called PowerSuite for comprehensive digital communications monitoring, analytics, reporting and management. Bellevue is also the home of another cloud developer, Acumatica, and this proximity helped Unify's Director of Global Finance/Corporate Controller, Elena Bespalova, to connect with the former and determine if the product could solve a very particular problem. As it happens,



Acumatica partner SWK Technologies faced a similar challenge with another client, and so Unify was referred to the VAR to see if their consultants would be able to address their unique situation – a multi-company and multi-currency financial operations chain. To solve the particular needs of Unify Square, which included finance reporting compliance for several countries, SWK would implement a multi-tenant cloud environment that would automate the multi-national accounting processes for Elena's team.

Unify Square is an international company, with offices across North America, Europe and Asia, including multiple overseas branches and subsidiaries of their headquarters and other locations. Consequently, the biggest requirement of their Acumatica implementation was

finding a way to consolidate their multi-currency accounting with their financial reporting at the US home base. This meant not only translating each transaction into dollars, but also ensuring the reports remained compliant with all the regulations in each nation.

These multi-company and multicurrency requirements meant that Unify Square would have to adopt a multi-tenant environment on a public cloud to accommodate and connect each national office.

In addition to each location's unique cloud environment, there would also have to be a way to for Elena and her team to consolidate ledgers across every office to produce unified reporting for the entire company.

Nick Heuer, who led Unify Square's Acumatica implementation, says that SWK was sought out for having experience with setting up multitenant cloud environments. However, the scope of Unify's infrastructure needs was greater than anything Nick had experienced before.

"It was a little mind boggling at first," says Nick. "It took me a while to figure out how to lay it out so we wouldn't have issues. We weren't just working with the multi-tenant environment, we were working with multi-tenant AND the multiple currencies."

Nick took a step back to review the situation, and realized that the multi -currency consolidation could be solved with Acumatica's native accounting functionality.

"It seemed a really big problem on the outside - but in reality, it wasn't too bad," says Nick. "Once I just started getting the framework of it in, it all fell into place."

Acumatica's out-of-the-box finance features could handle all the accounting functions, according to Nick, but Elena would require a tenants.

To handle this, both worked together on creating a separate "Consolidation tenant" that would map the various general ledger accounts to a consolidated ledger. With this, all the balances could be merged into master accounts and entered into a single financial statement.

Nick explains that the Consolidation tenant makes this a simple process without too much additional effort on the user's side.

"All you have to do is go to 'consolidations,' and then run a consolidation sync," says Nick. "Once it's configured, it's super easy. Elena just way to merge the data from the other goes in, and in a couple of clicks she's consolidating all the international tenants with the US accounting."

> Offices in each country work within their own tenant, which are kept in compliance with regional regulations to allow for seamless statutory reporting. The Consolidation tenant contains an OFFSET ledger that is used when differences appear between local regulations and Generally Accepted Accounting Principles (GAAP) in the US. Those transactions are reversed and modified to ensure final reporting is GAAP compliant.



"Setting up individual tenants for each country allows us to run reports that are compliant with local rules and also allows great flexibility into viewing consolidated financial results with a possibility of drilling down to individual transactions in each of the geographies," says Elena.

The only aspect of the implementation that was customized was a minor, but impactful adjustment of each tenant's coloring scheme to distinguish between each tenant's country. This further helps users consolidating accounts to work between each tenant without confusing one for the other.


"Visual differentiation between tenants is extremely helpful for a person who works with multiple tenants such as myself, and helps avoid mistakes of recording transactions into a wrong tenant," says Elena.



Even this modification was done within the existing framework provided by Acumatica, and Nick merely leveraged the features already there to personalize each tenant environment.

"For localization, we utilized the native functionality of Acumatica by setting the user profile settings in each tenant," says Nick. "AR invoices, AP bills – any system can handle that. It's the multi-tenant functionality that made it work for Unify."


The collaboration between SWK and Unify Square contributed greatly to the success of the implementation. Nick and Elena worked closely on refining the details of the multi-tenant environment.
